


## **2024 End of Year Report:** Activity Highlights & Updates

## **US-Africa** Policy

#### Advocating for Africa on the Global Stage

In 2024, AFJN participated in several high-level events, educating influential representatives from governments, the private sector, civil society, academia, and the public about critical issues affecting Africa.

#### **Key Events and Initiatives:**



**Combating Corruption:** AFJN co-sponsored a Civil Society Policy Forum side event, "Governance Reform Through Transparency: The Role of Civil Society in Combating Corruption" during the International Monetary Fund and World Bank 2024 Spring Meetings in Washington, DC.



**Land Grabbing and Sustainable Development:** AFJN Executive Director addressed the Ministerial Plenary at the 2024 United Nations (UN) Economic and Social Council (ECOSOC) High-Level Segment in New York, highlighting the impact of land grabbing on global food production targets and the importance of an integrated approach to the Sustainable Development Goals.



**Food Security and Faith:** AFJN Executive Director spoke as panelist during the "Pan African Future, Faith and the Vision of Food Security for All" presentation at the UN Future's Summit Black Futures Summit side event.



• **Empowering Women and Children:** AFJN's Women's Empowerment Coordinator participated in the "An Intergenerational Panel: Confronting Poverty Through Diverse Lenses" UN parallel event at the UN Conference on the Status of Women 68.

#### **Impactful Campaigns**

AFJN has been at the forefront of promoting justice, peace, community and faith-based engagement, and governance reform through various impactful campaigns. Key areas of US-Africa policy engagements include:



- **US-Kenya Strategic Trade and Investment Partnership Negotiations:** AFJN participated in public hearings and 'Stakeholder Listening' sessions organized by the US Trade Representative, the White House National Security Council's Office of African Affairs, and the President's Advisory Council on African Diaspora Engagement, raising concerns about transparency, regional economic integration, sustainable economic growth, and civil society inclusion.
- **Capitol Hill Advocacy Efforts:** AFJN collaborated with Congressional Offices, the Administration, key African Embassies, and civil society to address the volatile situation in the Democratic Republic of the Congo (DRC), including war crimes, humanitarian crises, and regional stability.
- Sanctions Against Rwanda: AFJN called the US to issue sanctions against Rwanda and other nations backing the M23 rebel group, as well as supporting the H.R. 8310: Bipartisan Building Relationships and Increasing Democratic Governance through Engagement to DRC Act of 2024.
  - **Refugee Resettlement Advocacy:** AFJN engaged with the White House National Security Council's Welcome Corps program to promote the resettlement of Africa refugees from conflict zones.
  - **Humanitarian Assistance and Elections Reform:** AFJN met with the US Department of State to advocate for increased humanitarian assistance to Sudan, and with the US Ambassador to Sierra Leone, Bryan David Hunt to discuss election reform efforts in Sierra Leone.

#### **Promoting Peace through Music in the Democratic Republic of Congo**

Despite facing a severe humanitarian crisis fueled by intensified conflict and heavy civilian casualties, citizens of the eastern Democratic Republic of Congo are leveraging their rich musical heritage to promote peace and unity. In 2024, AFJN launched the "<u>Unity Through Diversity</u>" program, encouraging youth to choose love, peace, and unity over division and conflict by leveraging their artistic expression to promote inclusive actions, and to celebrate and cultivate interculturality. Through this initiative, 30 musicians from nine ethnic groups came together for a seminar discovering how they may utilize their talent in spreading the message of peace and coexistence. The culmination of this collaboration was the multilingual song "Let Us Live Together" ("TUISHI PAMOJA BY AMP"), that urged listeners to reject tribalism and embrace unity. Building on this momentum, AFJN and Amahoro Youth (Peace Youth) co-hosted a concert promoting peaceful coexistence among diverse ethnic groups in eastern DRC, featuring a statement calling for peace.

> Carrying forward this energy, the Peace Caravan, organized by Artistes Musician for Paix (AMP) and AFJN traveled throughout Goma, North Kivu, spreading a powerful message of unity and coexistence. The caravan brought together nine ethnic groups, who visited displaced camps and debuted the "TUISHI PAMOJA BY AMP" in celebration of their shared heritage through music and dance.

#### **Enhancing Birth Registration and Certification in Cameroon**

UNICEF estimates that 1 of 3 children in Cameroon remain unregistered, posing significant risk of statelessness and limited access to education. AFJN is working to change this story. To address this issue, <u>AFJN forged several local partnerships</u> since 2019. In 2024, AFJN collaborated with the Cameroonian Catholic Ecclesiastical Province of Garoua and the Mayor of Foumbot to streamline the birth registration process, reducing the bureaucracy and extortion risks, in mainly Muslim communities where this problem is predominant. This partnership facilitated experience-sharing, challenge-identification, and process improvements. AFJN's newly formed Strategic Monitoring Committees ensure sustainability, and mobile courts have registered hundreds of children in Foumbot City and Kpouptamou. To promote awareness, AFJN brought the process closer to the people by distributing certificates at schools, engaging over 100 public school students and fostering a culture of inclusivity. These efforts align with Cameroon's broader initiative to improve civil registration and minimize statelessness among children.

#### Youth Empowerment: Preparing the Next Generation of Leaders

AFJN actively engaged youth across multiple countries through advocacy initiatives, educational programs, and empowerment projects. By sharing AFJN's expertise and experience, the organization aims to equip the next generation of leaders with the knowledge and skills necessary to combat social injustices and promote community development. In the US, AFJN staff shared their field expertise with university students, promoting a deeper understanding of African perspectives and women and youth empowerment. Meanwhile, in Africa, AFJN has expanded its advocacy awareness

programs to new countries and regions, addressing critical issues such as corruption, child marriage, domestic servitude, and land grabbing.

#### **Empowering Youth-Led Change in Nigeria**

Young people are the driving force behind AFJN's mission to combat early marriage and domestic servitude in Nigeria. In 2024, AFJN and AFJN-Nigeria, lead by women religious, collaborated to empower youth through advocacy training and awareness programs, in various states throughout Nigeria. This initiative sparked a ripple effect, as youth leaders took ownership of their newfound advocacy skills, sensitizing communities, advocating for change, and raising awareness on

pressing local issues. Key highlights of this initiative include training larger groups of youth leaders in cities like Akwa Ibom, engaging 723 youth and students, and equipping 231 youth in Ikwo LGA, Ebonyi State, to combat domestic servitude and child marriage. Other training activities focused on digital advocacy skills for the youth in Abuja. AFJN workshops in Enugu and Plateau educated 299 students on domestic servitude and empowerment culminating in advocacy visits to local leaders, including a local chief in Enugu and four Chiefs of the Gomai nation in Plateau. Through these efforts, AFJN remains committed

to fostering youth advocacy, promoting social justice, and addressing critical issues nationwide.

#### Bringing AFJN Youth Advocacy Workshops to Sierra Leone and Burkina Faso

In 2024 AFJN successfully launched its inaugural youth advocacy workshops in Sierra Leone and Burkina Faso. In Sierra Leone, AFJN collaborated with CARITAS Freetown, the Spiritan Development Office Ghana, and the Archdioceses of Freetown Catholic Youth Organization InterUnit to host "Building a Culture of Practical Advocacy: A Workshop for Catholic Youths in Sierra Leone." This workshop, rooted in Catholic social teaching, empowered 64 young Catholics from 29 parishes to become effective advocates for their communities, focusing on social justice issues such as land grabbing. Also in Burkina Faso, AFJN held the "Contribution a la consolidation de la paix durable par l'emploi des jeunes dans l'agriculture [Contribution to the consolidation of lasting peace through the employment of young people in agriculture]" youth-focused workshop which focused on agriculture as a catalyst for employment, peacebuilding, and sustainable development. Both workshops were well received and marked the beginning of AFJN's Just Governance youth advocacy programs in these countries.

#### Scaling Up Anti-Corruption Efforts: AFJN's Experience-Sharing Initiative in Liberia

At the invitation of the Bishop of Gbarnga, AFJN shared successful grassroots-led anticorruption strategies with the Diocese of Gbarnga in Liberia. In 2024, AFJN partnered with AFJN-Cameroon to conduct workshops and a comprehensive survey of five selected Catholic high schools, examining the impact of corruption on Liberia's education system. The survey, that engaged 250 stakeholders, revealed the education sector's vulnerability to patronage, bribery, and sexual exploitation. AFJN-Cameroon coordinator, Ms. Massa Ferancide shared valuable insights from Cameroon's grassroots-led anti-corruption strategy, adapting and replicating them in Liberia. Participants expressed interest in learning more about the project's success and grassroots approaches to combating corruption. The preliminary report, to be launched in April 2025, highlights corruption's significant impact on education outcomes. A diocese-wide engagement will follow later in 2025, aiming to spark meaningful change and promote just governance.

#### **Combating Land Grabbing and Promoting Sustainable Agriculture in Ghana and Sierra Leone**

In 2024, AFJN intensified its efforts to combat land grabbing and promote sustainable agriculture in Ghana and Sierra Leone.

#### **Ghana: Empowering Communities Against Land Grabbing**

In Ghana's Volta Region where AFJN visited seven villages, community leaders are taking the lead to protect their communities from predatory land deals. After several community town halls that attracted 340 community members, Paramount Togbega Lawluvi Bimah IV of Ziokpe, announced the formation of a committee to oversee foreign investment and prevent land grabbing. AFJN promoted regenerative agriculture as a better alternative, when considering food security, climate change, and small farm holders' economic wellbeing. Radio jingles that played in the neighboring countries sparked interest in AFJN's advocacy work.

#### Sierra Leone: Assessing the Impact of Multinational Land Acquisition

AFJN and its partners assessed the devastating impact of multinational land acquisition on rural communities in southern Sierra Leone. Through town hall meetings, AFJN listened to concerns about the operations of Socfin Agricultural Company Ltd. and FG Gold mining, that included toxic dumping, environmental degradation, and the loss of the local's livelihoods. Communities expressed a strong desire for advocacy training and collaboration opportunities, which AFJN plans to provide.

#### **Empowering Catholic Religious Leaders in Social Justice** Advocacy in the DRC, Kenya, Nigeria and Malawi

AFJN engaged Catholic religious communities in Nigeria, DRC, Kenya, and Malawi through advocacy training and empowerment initiatives. These included speaking at the Nigerian Major Superiors of Women Religious meeting, and meeting with seventy sisters in Benue State. These efforts focused on addressing social injustices, promoting governance accountability, and empowering religious leaders to drive systemic change. Key initiatives included training sessions, workshops, and direct engagements with government officials, community leaders, chiefs and faith leaders (including Imams).



#### Sensitization Efforts to Combat Early and Child Marriage and Domestic Servitude in Nigeria

AFJN-Nigeria, in collaboration with various partners, conducted extensive community sensitization programs across Nigeria to combat early and child marriage and domestic servitude. In Ebonyi State, events at the Bishop Thomas Mcgethric Pastoral Center and remote villages brought together hundreds of participants, including government officials, traditional rulers, and community leaders. These efforts highlighted the severe impact of these harmful practices, calling for government action and stronger community collaboration.

Similar initiatives were carried out in Jos, River State, and Port Harcourt, engaging religious leaders, human rights lawyers, and youth groups to raise awareness on women's and children's rights. The "Action Against Early Marriage, Domestic Servitude, and Domestic Violence" workshop in Port Harcourt educated the community on legal protections and social interventions. Through these programs, AFJN-Nigeria reinforced its commitment to eradicating these injustices through education, advocacy, and strategic partnerships. AFJN held similar efforts in Ghana in collaboration with AFJN-Ghana to tackle these issues.
