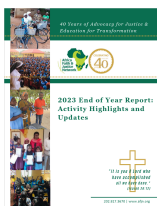


### Message from AFJN's Executive Director Dr. Steven Nabieu Rogers

## Presentation with Xavier University Students on Women Empowerment in Africa

On March 27, Sr. Eucharía Madueke, SNDdeN, AFJN Women Empowerment Project (WEP) Coordinator, gave a presentation to students at Xavier University during their Liberation Theology class on the work of AFJN in Africa. During the Zoom meeting, Sr. Eucharía explored questions like: What is liberation theology in relation to Africa and AFJN's WEP mission? and How does AFJN apply the concept of liberation when empowering African women? The students expressed amazement with the work of AFJN and asked many pertinent questions. They expanded their understanding of AFJN's mission in Africa especially in relation to the current project of ending early marriage and domestic servitude and have a new understanding of African women. Sister encouraged students to join AFJN in our mission and she shared stories of African youth activities to empower women and children.

## ILLICIT FINANCIAL FLOWS (IFFs) ARE IMPOVERISHING AFRICA

In the years 2008–2010, V. Van Den Bergh, a large Dutch multinational corporation operating in Kenya, evaded 13 billion Kenyan Shillings (22 million USD) in taxes. This practice is illegal under international law. It deprives the host country of a fair negotiating share of the goods produced from their natural resources and labor. And the company uses its institutional connections to lure it huge ill-gotten gains. *V. Van Den Bergh is only one of many multinational corporations that have set up industrial production of flowers in Kenya to be distributed internationally.* According to the Kenya Noses Agency, Kenya's multinational flower growers account for 71 percent of all earnings from the country's horticulture sector.

Example of a Case of Illicit Financial Flows from Kenya  
It was in 2016 that the Kenyan Revenue

It was in 2016 that the Kenya Revenue Authority, [Kenya's tax authority](#), found that Van Den Bergh Holdings BV, [headed Kenya's tax firm](#), was using the Van Den Bergh account and the sales of its flowers in the Dutch panoply at half the price they were worth – six below market rates – for at least four years. They charged, 10 Euros (11 US cents) per rose stem versus the market rate of 0.19 Euros (20 US cents) per stem. Van Den Bergh used its Kenyan branch to withhold profits in Kenya while selling at full price and reporting those [earnings in the Netherlands](#). The taxes in the Netherlands are much lower than the Kenyan rates. Over the years, this really added up and nibbled the Kenya host country. This story is [many forms of complex international crime](#) that, taken together, imperiched the continent.

## Public-Private Alliance for Responsible Minerals Trade (PPA)

In April, AFJN participated in the PPA's member briefing that included the current situation in the Democratic Republic of the Congo and minerals trading which is perpetuating the conflict and instability in the region. Members, especially those who are technology giants, were encouraged to do their due diligence to ensure that their end products do not contain conflict minerals from the DRC in accordance with the [requirements from the United States Security and Exchange Commission](#).

## Just Governance

## Cameroon



In January, the AFJN Just Governance Project helped 310 children register their births in Cameroon via a mobile court at a local school complex in Foubot City. Students from Kpouptamou City also assisted in the distribution of Certificates (from the June 16th registration event) at the nearby School Complex instead of City Hall. This strategic move drew attention to the importance of birth certificates, as many in attendance lacked this document. Afterwards, the AFJN team went to Kpouptamou

City Hall where over 100 public school students actively participated in the distribution of the certificates (also from the June 16th event) with the approval of the school system area inspector. Sixth-year students need their birth certificates to take the primary education national exam. The event was attended by many parents.

## Liberia



### Fighting Corruption in Liberia

In March, Dr. Rogers and AFJN's Cameroon Coordinator, Ms. Massa Ferencide, embarked on a preparatory visit to Liberia for this year's AFJN Just Governance workshops in the Diocese of Gbarnga. At the invitation of Bishop Tony Borwah, the team conducted a comprehensive survey and workshops in five selected Catholic high schools within the Diocese, examining the impact of corruption on the education system. Liberia's education sector is notoriously plagued by patronage, bribery, and sexual exploitation. A total of 250 stakeholders, comprising teachers, students, clergy, parents, PTA leaders, parish leaders, and school administrators, participated in the survey. Ms. Massa shared valuable insights and lessons learned from AFJN's grassroots-led anti-corruption project in Cameroon, which can be adapted and replicated in Liberia. Many participants expressed keen interest in learning more about the project's success and grassroots approaches to combating corruption. The report will be officially launched in the fall, followed by a diocese-wide engagement in December 2024, aiming to spark meaningful change and promote just governance.

This project is made possible by funding from the Raskob Foundation for Catholic Activities, Poor Handmaids of Jesus Christ and Sisters of the Holy Cross.

## Women Empowerment Project (WEP)

### Ghana - WEP



### Tamale

In March sisters revisited the 10 Northern Ghana communities they engaged in 2023. During the follow-up visit, sisters learned about the new policies implemented to protect young girls and children. In Pong Tamale sisters met with 53 youths (students, female apprentices, and town youth) and 10 adults (representatives of the Chief and opinion leaders). In Diare, following our advocacy engagement, the Chief and Elders made bylaws that included: banning 3-days music and dancing; implementing a 10:00 pm curfew for youth and children that would send rule breakers to the Chief's Palace and that fined their parents; and the creation of a task force of volunteers patrol the community at night. The Chief, individuals, and community groups were happy and grateful to AFJN for bringing these issues to



light. In Bogkurugu, following our sensitization event, the Chief and Elders decided to fine families, to make families more conscious about the movement and behaviors of their children. According to the Chief, a decree was made in the community that any family whose girl child became pregnant will be fined a sheep and some amount of money. He added that many children have been enrolled in the school (many were observed at home during our first visit). The Chief and Elders stressed that this law has come to stay in Bogkurugu and expressed their sincere gratitude to AFJN-Ghana.

In April, a one-day community advocacy workshop was held for 20 participants from 6 communities. During this workshop participants created a strategic plan for their community engagement.

## Kenya - WEP



In April the Women Empowerment Project held advocacy training workshops, with over 56 sisters (from all parts of Kenya and members of the Association of Sisterhoods of Kenya) and a traditional chief, on the challenges facing women and girls like: femicide, underage marriage, gender-based violence (GBV) and more. The executive secretary of the conference of women religious welcomed the sisters, and a young chief spoke on the challenges facing women and girls, insisting that the government needs to act but also that the sister must do more to prevent it from escalating. The participants met with The Cabinet Secretary for Gender Honorable Aisha Jumwa and the National Council for the Administration of Justice (NCAJ), presenting a Memorandum that urged strong measures, policies and programs to prevent and respond to the rampant cases of GBV across the country. The sisters were well received and media were invited to cover the events.

## Malawi - WEP



In January, at the invitation of the Conference of Women Religious in Malawi, AFJN led an advocacy training workshop for sisters (including sisters from Zambia and Zimbabwe). The focus of the event was to work with the sisters in social analysis and advocacy. On the first day over eight media outlets covered the event. The Minister of Trade and Industry pleaded with the sisters to work with him on these 'top priority' issues (that the sisters addressed) during their advocacy visit. He revealed that when the sisters speak people listen. The sisters were calling for more government accountability and for the government to address the needs of the people, lifting vulnerable voices, and to work for the common good. During the sisters visit to the Ministries of Gender and Home Affairs, they asked for the creation of an environment to ease youth suffering to reduce youth divide cases. Following the workshops and advocacy visits the sisters shared how they have found new confidence in speaking out with the knowledge they have gained.

## Nigeria - WEP

### Major Superiors Meeting

In January, AFJN was invited to speak during the Major Superiors of Women Religious meeting in Nigeria about the Women Empowerment Project. Fr. Aniedi Okure, OP, WEP Consultant, gave the rundown of AFJN, the origin of WEP, and its activities in Nigeria. Sr. Eucharist spoke about the current and future projects, with engagement from major superiors. Two of the major superiors were AFJN members before they became Mother generals and a major superior from Ghana also spoke highly of the work in Ghana.



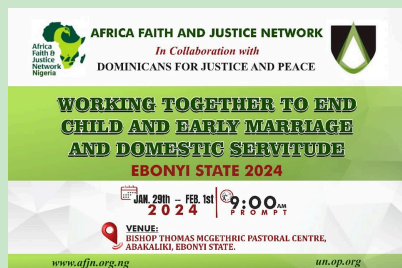


## Akwa-Ibom State

In March, AFJN and AFJN-Nigeria held a stakeholder meeting on Domestic Servitude and Child Marriage in Akwa-Ibom State. The team, meeting with the Council of Chiefs in the Ibiono Ibom Local Government Area, addressed the detrimental impacts of domestic servitude and early child marriage and highlighted the urgent need to combat these practices emphasizing the importance of community collaboration in effecting positive change. The chiefs expressed their support and commitment to these issues. This collaborative effort is a significant step towards fostering awareness, advocacy, and collective action in the state. The AFJN-N team extended an invitation to the Council of Chiefs for their May stakeholders meeting and the chiefs pledged their attendance, demonstrating a shared dedication to advancing social justice and protecting vulnerable members of society.



## Ebonyi State



From January 29 to February 1, 2024, AFJN, AFJN-Nigeria, and the Dominicans for Justice and Peace held "Working Together to End Child and Early Marriage and Domestic Servitude" at the Bishop Thomas Mcgethric Pastoral Centre, in Abakaliki. Speakers included: Rev. Dr. Flora Obia Egwu, the Deputy Coordinator of the Ebonyi State Gender-Based Violence Response Team (Task Force), Pastor Gabriel Odom,

Coordinator of the Child Protection Network, Fr. Okure, and Sr. Eucharía. Representatives from the Ebonyi State Government also participated. In one community engagement, the team met with over 300 people. The event was covered live on Unity FM 101.5FM!

They also made advocacy visits to key leaders, stakeholders, and government officials. Many vowed to collaboration with the group.

His Royal Highness Eze Charles Mkpuma, Chairman of the Ebonyi State Traditional Rulers Council promised to invite AFJN to the traditional chief's meeting where they can sensitize them on the detrimental consequences of domestic servitude and child marriage and share the letter - the blueprint for action.

Hon. Commissioner Barr. Mrs. Felicia Nwamkpuma of Women Affairs and Social Development in Ebonyi State vowed to eradicate domestic servitude and child marriage in the state and will work with AFJN-Nigeria and the community to tackle these pressing issues.

Following the advocacy visit and possible collaboration with the Vice President General Supreme Council for Islamic Affairs, Hon. Dr. Haroun O. Ajah, the Ebonyi State Islamic Council sent a message that "The Da'wah and

Guidance Bureau of Nigeria (DGBN) is ready to collaborate" on this agenda "especially the Muslim Communities in the country."

During the visit with Dr. Moses Ekuma, the Honorable Commissioner for Health and Commissioner of Police Mrs. Augustina Ogbodo, the team they discussed ways that the government can contribute to addressing these issues.

On February 12, AFJN, AFJN-Nigeria, Dominicans for Justice and Peace, and the Women and Child Justice Initiative Nigeria (WOCJIN) took it's sensitization program to the remote village of Ndibokoto Village in Ezza, Inyimegu Izogo Ward, Izzi Local Government Area where early child marriage and domestic servitude is rampant. People were living in poverty, malnourished, lacking access to education and other resources. The team called on the government to act to resolve this crisis.

These young leaders are inspired to help drive transformative change in their communities.

### Plateau State



In February, AFJN-Nigeria Jos held and advocacy planning meeting at the Center for Renewal to address the issues of early marriage and domestic servitude in Miango Jebu. During the meeting they identified various stakeholders, scheduled grassroots discussions and mobilization. They also recognized the need to expand to the Shendam Diocese and identified sisters who will lead the collaboration in the area and set dates for future planning meetings. The

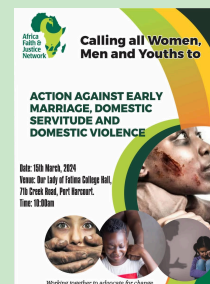
team also set membership goals, increased participation and outreach to engage youth from other denominations and parishes with the aim to advocate for change and create a safer environment for the vulnerable populations.





## River State

In March, AFJN-Nigeria sisters, women, men and youth held "Action Against Early Marriage, Domestic Servitude and Domestic Violence" workshops at Our Lady of Lourdes Catholic Church in Port Harcourt, River State. Speakers included Ms. Patricia Ijeh, Sr. Fidelia Mary Alao EHJ, and Barr. Aimole Uju (a Human Rights Lawyer). The event sensitized the community on the rights of women and children. ## Office Retreat

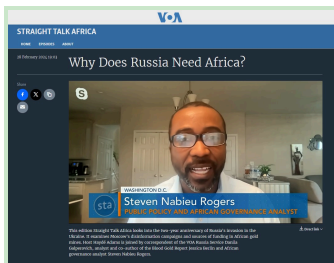
